2018 DETROIT BUICK GMC PICK YOUR STYLE SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. THE 2018 DETROIT BUICK GMC PICK YOUR STYLE SWEEPSTAKES (THE "SWEEPSTAKES") BEGINS AT 12:00 A.M. CENTRAL STANDARD TIME ("CST") ON JANUARY 19, 2018, AND ENDS ON JANUARY 4, 2019, AT 11:59 P.M., CST (THE "PROMOTIONAL PERIOD"). WHEN APPLICABLE, ADMINISTRATOR'S COMPUTER WILL BE THE OFFICIAL TIME-KEEPING DEVICE FOR THE SWEEPSTAKES. **First Prize Winners will be required to attend the January 12, 2019, Grand Prize Drawing at the North American International Auto Show to be eligible to win the Grand Prize.** You should not enter this Sweepstakes if you are not able to attend the Drawing on January 12, 2019.

Email And Social Media Posts: In addition to visiting a participating Detroit Buick GMC Dealership during the Promotional Period, each participating dealership will have its own individual online media promoting the Sweepstakes. FIRST PRIZE WINNER SELECTION: Administrator will select, via a random drawing on or about January 7, 2019, a total of ten (10) potential First Prize Winners from among all eligible entries received during the Promotional Period, subject to verification and compliance with these Official Rules. Each of the up to ten (10) First Prize Winners will be required to

be present and checked in at the final Grand Prize Drawing at the North American International Auto Show lobby in Detroit, Michigan (1 Washington Blvd, Detroit, MI 48226), where the Grand Prize Winner will be announced. If a First Prize Winner does not attend the Drawing for any reason, he or she is not eligible to receive the Grand Prize. **MUST BE PRESENT TO WIN THE GRAND PRIZE.** First Prize Winners cannot transfer their chance to win the Sweepstakes to another individual. First Prize Winners will receive an opportunity to attend the North American International Auto Show, and a chance to win the Grand Prize. First Prize Winners will be contacted by the Administrator by telephone and/or email and will be required to complete and return an affidavit of eligibility, liability, and use of likeness release, and except where prohibited by law, a publicity release form ("affidavit/release") within three (3) days of receipt. If any of the potential First Prize Winner's notifications are rejected, returned, or deemed undeliverable or a potential First Prize Winner fails to execute and return the affidavit/release within the specified time or if he/she is otherwise ineligible to receive the prize, that potential First Prize Winner will be deemed ineligible and a replacement may be randomly selected by Administrator from among the remaining eligible entries, time permitting.

It is anticipated that there will be a total of ten (10) First Prize Winners, but this number could change based on various factors such as a First Prize Winner being deemed ineligible or unable to attend the Grand Prize drawing.

FIRST PRIZE: Each First Prize Winner will receive:

- One (1) ticket to the 2019 North American International Auto Show in Detroit, Michigan.

Approximate Retail Value ("ARV") of each First Prize: \$12.00. Additional expenses, including travel to/from the Grand Prize Drawing, parking fees, taxes, or other fees and costs not explicitly mentioned, are not included in the First Prize.

The odds of a particular entrant being selected as a First Prize Winner depends on the number of eligible entries received during the Sweepstakes.

GRAND PRIZE WINNER SELECTION/VERIFICATION: Each of the up to ten (10) First Prize Winners will be required to be present and checked in at the final Grand Prize Drawing on January 12, 2019, to win at the North American International Auto Show in Detroit, Michigan, where the Grand Prize Winner will be announced. If a First Prize Winner does not attend the Drawing for any reason, he or she is not eligible to receive the Grand Prize.

All First Prize Winners must present themselves to a Sweepstakes Sponsor representative for Drawing registration and present a valid government-issued photo identification. If the Potential Grand Prize Winner's notification is rejected, returned, or deemed undeliverable or the potential winner fails to execute and return the affidavit/release within the specified time or if he/she is otherwise ineligible to receive the Grand Prize, that potential winner will be deemed ineligible and the Prize will be awarded to an alternate selected at an alternate drawing from all remaining eligible First Prize Winners. Alternate winner will be subject to the same requirements. Subject to verification of eligibility and compliance with the terms of these Official Rules, the potential Grand Prize Winner will be declared the official winner of the Grand Prize (the "Grand Prize Winner"). Unclaimed Prizes will not be awarded.

GRAND PRIZE: One (1) Grand Prize Winner will receive a twenty-four (24) month lease on one (1) 2019 GMC Terrain or a 2019 Buick Enclave (hereinafter the "Vehicle") The Grand Prize Winner will be required to sign a vehicle lease through Sponsor's or dealers approved leasing company of choice, which may have additional terms and conditions. Lease

agreement consists of a maximum 10,000 miles per year during the twenty-four (24) month Lease. The Grand Prize Winner will be solely responsible for any additional costs associated with the Vehicle, including, without limitation, all federal, state and local taxes on the vehicle, title, tax, license, PDI (pre-destination inspection), registration, shipping, insurance, mileage that exceeds ten thousand (10,000) per year and any additional accessories and options as agreed to between winner and the authorized Buick GMC dealership location at which the Vehicle will be delivered, as determined by the Sponsor in its sole discretion. In the event the Grand Prize Winner's lease has a lesser value than twenty thousand dollars (\$20,000.00) the Grand Prize Winner will not receive the difference between the actual value of the lease on such vehicle and the value of the 24-month lease stated herein. Grand Prize Winner will be responsible for pick-up of the Vehicle at a time and location determined in the sole discretion of the Sponsor (Sponsor will endeavor, as a courtesy, to select a Buick GMC dealership close to the residence of the Grand Prize Winner, as determined by Sponsor in its sole discretion). Grand Prize Winner must complete all documentation required by Sponsor to take possession of the Vehicle. At time of award of Vehicle, Grand Prize Winner (i) will assume lease ownership of and responsibility for the Vehicle; (ii) will be required to sign various documents involving the Vehicle; and (iii) must furnish proof of residence, a valid driver's license as required by the law of the Grand Prize Winner's jurisdiction of residence and of the jurisdiction of pickup, and any required insurance coverage. Grand Prize Winner must complete a credit application for the 24-month lease and must have a qualifying credit rating. If the Grand Prize Winner does not meet the credit requirements of the lease agent, an alternate winner will be selected by random drawing from among the remaining eligible First Prize Winners. Grand Prize Winner is solely responsible for determining the class of license necessary to legally operate the Grand Prize. Grand Prize Winner is solely responsible for complying with any applicable federal, state and/or local laws and regulations applicable to the Vehicle, including without limitation registration requirements and operating restrictions. Sponsor reserves the right to withhold delivery of the Vehicle if the Grand Prize Winner does not comply with the above requirements and Grand Prize may be forfeited, in Sponsor's discretion, by Grand Prize Winner's such noncompliance. If the Grand Prize winner chooses not to accept the lease, they may take the cash buyout option of \$1,500.00. The Approximate Retail Value of Grand Prize: up to \$20,000.00.

The odds of a particular First Prize Winner winning the Grand Prize are not to exceed 1 in 10, or 1 in the number of First Prize Winners participating in the Grand Prize drawing if less than 10 participate due to ineligibility.

GRAND PRIZE RESTRICTIONS: The Sponsor will not provide any additional verbal or written warranties other than the standard written New Vehicle Limited Warranty provided with the Vehicle. Any difference between the stated value and actual value of the prize will not be awarded to the Winner. No cash or vehicle substitutes and no cash rebates. Lease cannot be assigned or transferred to a third party. Vehicle delivery is through an authorized Buick GMC dealer and conditional upon winner's execution and return of leasing company's customary motor vehicle lease documentation (including its standard consumer motor vehicle lease agreement and credit application). The vehicle must be returned at the end of the 24-month lease term. Winner will be responsible for pick up and return of Vehicle at time and location determined in the sole discretion of leasing company. Pictures, display vehicles or other representations of any vehicle used in connection with this Sweepstakes are not depictions or promises of the Prize, which may differ substantially.
