2019 CHEVROLET CMA AWARDS® SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. 2019 CHEVROLET CMA AWARDS® SWEEPSTAKES (THE "SWEEPSTAKES") BEGINS AT 10:00 A.M. CENTRAL STANDARD TIME ("CST") ON MARCH 7, 2019, AND ENDS ON OCTOBER 20, 2019, AT 10:00 A.M., CST (THE "PROMOTIONAL PERIOD"). ADMINISTRATOR'S COMPUTER WILL BE THE OFFICIAL TIME-KEEPING DEVICE FOR THE SWEEPSTAKES.

ALL OTHERS ARE INELIGIBLE TO ENTER AND WILL BE DISQUALIFIED. VOID WHERE PROHIBITED OR RESTRICTED. VIA ONLINE: Visit www.2019chevyCMAawardssweeps.com (the "Website") during the Promotional Period and complete the online entry form with the required contact information (first and last name, mailing address, email, and phone number

(optional) and submit as directed ("Website" entry). WEBSITE ENTRIES MUST BE SUBMITTED AND RECORDED BY 10:00 A.M. CST ON OCTOBER 20, 2019.

On-site Entries and Online Entries are hereinafter referred to as "Entry" or "Entries."

LIMIT: ONE (1) ENTRY PER PERSON REGARDLESS OF METHOD OF ENTRY. Online Entries will be deemed made by the authorized account holder of the email address submitted at the time of Entry. The authorized account holder is the natural person who is assigned to the email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses or the domain associated with the submitted email address.
