

OFFICIAL RULES

AE SUMMER SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. *AE SUMMER SWEEPSTAKES* (THE "SWEEPSTAKES") BEGINS AT 12:00 A.M. CENTRAL DAYLIGHT-SAVING TIME ("CDT") ON AUGUST 1, 2018, AND ENDS ON SEPTEMBER 1, 2018 AT 11:59 P.M., CDT (THE "PROMOTIONAL PERIOD"). ADMINISTRATOR'S COMPUTER WILL BE THE OFFICIAL TIME-KEEPING DEVICE FOR THE SWEEPSTAKES.

ELIGIBILITY: THE SWEEPSTAKES IS OPEN ONLY TO LEGAL RESIDENTS OF THE STATE ILLINOIS, INDIANA, IOWA, KENTUCKY, MICHIGAN, MINNESOTA, MISSOURI, TENNESSEE, AND WISCONSIN WHO ARE 21 YEARS OF AGE OR OLDER, WITH A VALID DRIVER'S LICENSE OR A VALID GOVERNMENT-ISSUED PHOTO I.D. AT TIME OF ENTRY ("ENTRANT"). ALL OTHERS ARE INELIGIBLE TO ENTER AND WILL BE DISQUALIFIED. VOID WHERE PROHIBITED OR RESTRICTED. Employees of Accel Entertainment ("Sponsor"), Synergy Marketing Partners ("Administrator"), and their respective parents, affiliates, subsidiaries, distributors, and their advertising and promotion agencies (collectively the "Released Parties") and the members of their immediate families (spouses and parents, siblings, children and their spouses and in-laws) and persons living in the same household with such individuals (whether related or not) are not eligible to enter or win. Owners, individuals disclosed on the Participating Establishment's Illinois Gaming Board application, and employees of (or individuals who serve in a voluntary capacity at) Participating Establishments may be eligible to enter or win but may not enter to win at the Participating Establishment they own, are listed on the application of, or at which they are employed (or volunteer).

AGREEMENT TO THE OFFICIAL RULES: By participating, Entrants agree to be bound by these Official Rules and the decisions of the Sponsor and/or Administrator, which are binding and final on all matters relating to this Sweepstakes. This Sweepstakes is subject to all applicable federal, state, and local laws. Winning a prize is contingent upon fulfilling all requirements set forth herein.

TO ENTER: There are two (2) ways to enter the Sweepstakes:

ON-SITE ENTRY: Visit any of the participating Central, North, or South Regional establishments that operate Accel Entertainment video gaming machines during the Promotional Period ("Participating Establishment") and during the Participating Establishment's regular posted business hours to complete an Official Entry Form by providing the requested information (first and last name, mailing address, phone number, and email address) ("Entry") and submit as directed. Incomplete Entries are void. ENTRIES MUST BE RECEIVED BY SEPTEMBER 1, 2018, BY 11:59 P.M. CDT. There is no purchase or fee required to enter. For a list of all Participating Establishments, please visit (www.synmp.com/rules). On-Site Entry must be made by the Entrant as detailed above. Limit One (1) On-Site Entry per person, per day, per Participating Establishment for the Sweepstakes.

MAIL-IN ENTRY: Alternatively, Entrants can enter the Sweepstakes during the Promotional Period by legibly hand printing their name on a plain piece of 3" x 5" paper, including their first and last name, complete street address (no P.O. boxes) including zip code, and daytime phone number, and mailing it in an envelope with first class postage affixed to: "AE SUMMER SWEEPSTAKES", c/o SYNMP, 100 W. 22nd Street, Suite 134, Lombard,

Illinois 60148. ("Mail-In Entry"). No mechanically reproduced entries will be accepted. No metered mail and one (1) entry per postmarked outer mailing envelope. Mail-In Entries must be post-marked by September 1, 2018 and received by September 6, 2018. Illegible or incomplete Mail-in Entries are void. Subject to the outer mailing envelope restrictions above, there is no limit to the number of Mail-in Entries per person.

On-site and Mail-In Entries are collectively hereinafter referred to as "Entry" or "Entries."

Entries made by any other individual or any entity, and/or originating at any other event or method, including but not limited to commercial sweepstakes subscription notification and/or entering service websites, will be declared invalid and disqualified for this Sweepstakes. In the event a dispute regarding the identity of the individual who actually submitted an Entry cannot be resolved to Sponsor's satisfaction, the affected Entry will be deemed ineligible.

Only Entries submitted in accordance with these Official Rules will be accepted. No telephoned, faxed, emailed, or mechanically reproduced Entries, or Entries generated by any means which subvert the entry process, will be accepted. Administrator, Sponsor and Participating Locations are not responsible for lost, late, incomplete, invalid, unintelligible, unreadable, or misdirected registrations, which will be disqualified. All Entries become the exclusive property of the Sponsor and will not be acknowledged or returned. Administrator has no obligation to advise an Entrant of an incomplete or otherwise non-compliant Entry.

FINALIST SELECTION: Administrator will select, via a random drawing on or about September 6, 2018, a total of fifty (50) potential finalists/winners ("Finalists") from among all eligible Entries received, subject to verification and compliance with these Official Rules. THE ODDS OF A PARTICULAR ENTRANT BEING SELECTED AS A FINALIST DEPEND ON THE NUMBER OF ELIGIBLE ENTRIES RECEIVED.

FIRST PRIZE: Each Finalist will receive:

Approximate Retail Value ("ARV") of each First Prize: \$500.00

Approximate Retail Value ("ARV") of the total of all First Prizes: \$25,000.00

In addition, each of the up to fifty (50) Finalists will receive an opportunity to attend the final Grand Prize Drawing at Starved Rock Yacht Club (1200 N. 27th Road, Ottawa, Illinois 61350) on September 22, 2018 at 12:00 P.M. CDT (the "Grand Prize Drawing"), where the Grand Prize Winner will be announced. Additional expenses, including travel to/from the Grand Prize Drawing, parking fees, taxes, or other fees and costs not explicitly mentioned, are not included in the First Prize.

If a Finalist does not attend the Grand Prize Drawing event for any reason, he or she is allowed one (1) designated proxy to represent them at the Grand Prize Drawing. Finalists will be contacted by the Administrator by telephone and/or email and will be required to complete and return an affidavit of eligibility, liability release, and use of

likeness release, and except where prohibited by law, a publicity release form ("affidavit/release") within three (3) days of receipt. If any of the potential Finalist's notifications are rejected, returned, or deemed undeliverable or a potential Finalist fails to execute and return the affidavit/release within the specified time or if he/she is otherwise ineligible to receive the Grand Prize, that potential Finalist will be deemed ineligible and a replacement may be randomly selected by Administrator from among the remaining eligible Entries, time permitting.

GRAND PRIZE WINNER SELECTION/VERIFICATION: It is anticipated that there will be a total of fifty (50) Finalists for the Grand Prize Drawing, but this number could change based on various factors such as a Finalist being unable to attend. Each of the up to fifty (50) Finalists, or designated proxy, must personally appear and present themselves to an Administrator and/or Sponsor representative at the Grand Prize Drawing at the Starved Rock Yacht Club (1200 N. 27th Road, Ottawa, Illinois, 61350) on Saturday, September 22, 2018 by 12:00 P.M. If the Potential Grand Prize Winner's notification is rejected, returned, or deemed undeliverable or the potential winner fails to execute and return the affidavit/release within the specified time or if he/she is otherwise ineligible to receive the Grand Prize, that Potential Grand Prize Winner will be deemed ineligible and the Grand Prize will be awarded to an alternate Finalist selected at an alternate drawing from all remaining eligible Finalists. Alternate Potential Grand Prize Winner will be subject to the same requirements. Subject to verification of eligibility and compliance with the terms of these Official Rules, the Potential Grand Prize Winner will be declared the official winner of the Grand Prize (the "Grand Prize Winner").

Administrator reserves the right, at its sole discretion, to disqualify any suspect Entry or Entrant and to cancel, terminate, modify, or suspend, the Sweepstakes and randomly select the winner from valid entries received prior to action taken, or otherwise as may be deemed fair and equitable by the Sponsor in its sole discretion. In the event of any cancellation, termination or suspension, notice thereof will be posted at <http://www.synmp.com/rules>. Entries not complying with all rules are subject to disqualification. Administrator reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. If any provision(s) of these Official Rules is held invalid or unenforceable, all remaining provisions hereof will remain in full force and effect.
