

# OFFICIAL RULES

## CMA MUSIC FESTIVAL® ULTIMATE FAN SWEEPSTAKES

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.** THE CMA MUSIC FESTIVAL ULTIMATE FAN SWEEPSTAKES (THE "SWEEPSTAKES") BEGINS AT 10:00 A.M. CENTRAL STANDARD TIME ("CST") ON MAY 8, 2017, AND ENDS ON JUNE 1, 2017, AT 11:59 P.M., CST (THE "PROMOTIONAL PERIOD"). ADMINISTRATOR'S COMPUTER WILL BE THE OFFICIAL TIME-KEEPING DEVICE FOR THE SWEEPSTAKES.
