

# OFFICIAL RULES HYUNDAI CATCH A KONA SWEEPSTAKES

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**ELIGIBILITY:** THE *HYUNDAI CATCH A KONA SWEEPSTAKES* (THE "SWEEPSTAKES") IS OPEN ONLY TO LEGAL RESIDENTS OF TENNESSEE WHO, AT THE TIME OF ENTRY, ARE EIGHTEEN (18) YEARS OF AGE OR OLDER AND HAVE A VALID DRIVER'S LICENSE AT THE TIME OF ENTRY ("ENTRANT"). ALL OTHERS ARE INELIGIBLE TO ENTER OR WIN AND WILL BE DISQUALIFIED. VOID WHERE PROHIBITED OR RESTRICTED. **HOW TO ENTER:** There are two (2) ways to enter the Sweepstakes during the Promotional Period: on-site at select Nashville Sounds Home games during the Promotional Periods mentioned above or online at the website detailed below. No other method of entry will be accepted. Entries will not roll over into the next entry period. Sponsor is not responsible for lost, late, illegible, stolen, incomplete, invalid or unintelligible entries. Proof of submission will not be deemed to be proof of receipt by Sponsor.

**On-site:** Entry forms and entry boxes will be available at the Hyundai Vehicle Display Area (the "Display Area") located under (or near) the scoreboard at First Tennessee Park (19 Junior Gilliam Way, Nashville, TN 37219) at the following Nashville Sounds home games (each a "Game" and collectively the "Games"):

The Display Area will be open on game day approximately one hour before the first pitch at each of the Games and will close after the final out of the bottom of the seventh inning (the "Open Hours"). To enter Sweepstakes, visit the Display Area during Open Hours at any designated Game, complete a Sweepstakes entry form by filling out first name, last name, mailing address, email, phone, and age. Entrant must also provide their vehicle of interest, purchase horizon, and if the entrant owns a vehicle. Place the entry form into the entry box at the Display Area. Official Game times can be found at [www.NashvilleSounds.com](http://www.NashvilleSounds.com) and are subject to change.

Sponsor may not have a display area at all Games, events and locations and reserves the right to add, change, and/or cancel, its intentions to have a display area at any or all of the above listed locations, at any time, without notice. If there is no display area at a Game, Entrants should submit an Online entry as set forth below.

**Online:** Alternatively, Entrants may enter the Sweepstakes without attending a game by visiting the website [www.hyundaicatchakona.com](http://www.hyundaicatchakona.com) (the "Website") during the Promotional Period and complete the online entry form with the required contact information and submit as directed ("Online entry").

Entries must contain all information requested and comply with all applicable restrictions or requirements set forth herein to be valid. Entries must be submitted and recorded during an Entry Period and prior to the drawing time to be eligible for that Entry Period's drawing. Entrants must agree to these Official Rules to submit an Entry into any Entry Period.

You do not need to be present at any Game to win a prize.

On-site and Online entries are collectively referred to as "Entry" or "Entries" herein.

**FIRST PRIZE WINNER SELECTION:** Administrator will select, via a random drawing per the drawing schedule above, one (1) Potential Weekly First Prize Winner ("Weekly Winner"), from among all eligible entries received during that Entry Period, subject to verification and compliance with these Official Rules for a total of five (5) potential Weekly Winners. The five (5) Weekly Winners will receive an opportunity to attend the Nashville Sounds home game on September 1, 2019, and a chance to win the Grand Prize. Each potential Weekly Winner will be contacted by the Administrator by telephone and/or email and will be required to complete and return an affidavit of eligibility and liability release form ("affidavit/release") within three (3) days of receipt. (Approximate Retail Value ("ARV") of each First Prize: \$330.00) Additional expenses, including travel to/from the game, taxes, or other fees and costs not explicitly mentioned, are not included in the First Prize and will be the responsibility of the Weekly Winner. Sponsor, in their sole discretion, will determine seating locations and details.

CST on Thursday, August 29, 2019. **WEEKLY WINNER OR DESIGNATED PROXY MUST BE PRESENT AT GRAND PRIZE DRAWING TO WIN THE GRAND PRIZE AND WEEKLY WINNER IS RESPONSIBLE FOR ALL TRAVEL COSTS ASSOCIATED WITH THE WEEKLY WINNER'S/DESIGNATED PROXY'S ATTENDANCE OVER AND ABOVE THE TICKET COSTS AND PARKING.** Proxy's will receive one of the First Prize Winner's tickets to attend the game as well as the parking pass. **GRAND PRIZE WINNER SELECTION/VERIFICATION:** If a Weekly Winner does not attend the Drawing at the First Tennessee Park (19 Junior Gilliam Way, Nashville, TN 37219) on Sunday, September 1, 2019 by 5:30 P.M. for any reason, his or her previously identified proxy is allowed to represent him or her at the Drawing.
