

OFFICIAL RULES

HYUNDAI ELANTRA 6TH INNING SLAM SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

Start times are subject to change due to the Nashville Sounds schedule. The Sweepstakes consists of a First Prize Sweepstakes and a Grand Prize Sweepstakes, as set forth below.

The Display Area will be open on game day approximately one hour before the first pitch at each of the Games, and will close after the final out of the bottom of the fifth inning (the "Open Hours"). To enter Sweepstakes, visit the Display Area during Open Hours at any designated Game, complete a Sweepstakes entry form by filling out first name, last name, mailing address, email, phone, and age. Entrant must also provide their vehicle of interest, purchase horizon, and if the entrant owns a vehicle. Place the entry form into the entry box at the Display Area. Official Game times can be found at www.NashvilleSounds.com and are subject to change.

Sponsor may not have a display area at all Games, events and locations and reserves the right to add, change, and/or cancel, its intentions to have a display area at any or all of the above listed locations, at any time, without notice.

Online: Alternatively, Entrants may enter the Sweepstakes without attending a game by visiting the website www.Hyundaigiveaway.com (the "Website") during the Promotional Period and complete the online entry form with the required contact information and submit as directed ("Online entry"). ONLINE ENTRIES MUST BE SUBMITTED BEGINNING ONE HOUR BEFORE THE FIRST PITCH AND BEFORE THE FINAL OUT AFTER THE BOTTOM OF THE FIFTH INNING OF THE DESIGNATED NASHVILLE SOUNDS GAMES identified above.

Complete the foregoing step(s) to receive: one (1) entry into the corresponding First Place Entry Period and one (1) entry into the corresponding Grand Prize Drawing. The First-Place prize opportunity will end after the July 2, 2017, game and, thereafter, Entries will solely be entering the Grand Prize Sweepstakes.

Entries must contain all information requested and comply with all any applicable restrictions or requirements set forth herein to be valid. If the Sounds do not hit a grand slam during the Game, then there will be no winner for that Game. There is a limit of one Grand Prize Winner for the entire Sweepstakes. All non-winning Grand Slam Prize Entries will automatically roll-over to subsequent games (Entry Periods).

The in-stadium PA will announce the Grand Prize Winner and will provide instructions on how to claim their Grand Prize at the Stadium. If Grand Prize Winner is not present at the Game, Grand Prize Winner will be notified by email or telephone (at Administrator's discretion). Entrants need not be present to win. If there is no a Grand Slam Home Run during the 6th inning during the entire Promotional Period, then no Grand Prize Will be awarded in this Sweepstakes.
