

# OFFICIAL RULES

## ACDELCO RIDE RACE REWARDS SWEEPSTAKES

**NO PURCHASE NECESSARY TO ENTER OR WIN.** PURCHASING A PRODUCT OR SERVICE WILL NOT INCREASE YOUR CHANCES OF WINNING. EACH SWEEPSTAKES ENTRY WILL HAVE AN EQUAL CHANCE OF WINNING A PRIZE.

**ELIGIBILITY:** THIS PROMOTION IS OFFERED ONLY IN THE UNITED STATES AND IS OPEN ONLY TO THE FOLLOWING PERSONS ("ENTRANT" OR "ENTRANTS"):

A: CONSUMERS: "Consumer" shall be defined in these official rules as persons who are legal residents of the fifty (50) United States and District of Columbia who, at the time of entry, are at least 18 years of age or have reached the age of majority at the time of entry.

**MONTHLY PRIZE WINNER SELECTION:** At the completion of each Monthly Entry Period, on or about the Drawing Date listed above for such Monthly Entry Period the Administrator will select: one (1) potential First Prize monthly prize winner; two (2) potential Second Prize monthly winner; one (1) potential Third Prize monthly winners; four (4) potential Fourth Prize winners; twenty-four (24) potential Fifth Prize monthly winners, and fifty (50) potential Sixth Prize winners; one hundred (100) potential Seventh Prize winners; in a random drawing from among all eligible Entries received during such Monthly Entry Period. There will be one hundred and eighty-two (182) Monthly Prize Winners (as defined below) for each Monthly Entry Period, for a total of five-hundred forty-six (546) Monthly Prize Winners (the "Monthly Prize Winners").

**GRAND PRIZE WINNER SELECTION:** At the completion of each Grand Prize Entry Period, on or about the Drawing Date listed above for such Grand Prize Entry Period, the Administrator will select one (1) potential grand prize winner in a random drawing from among all eligible Entries received during such Grand Prize Entry Period.
